Office of Developmental Disabilities Ombuds

Legislative intent SB 6564

"The legislature finds and declares that the prevalence of the abuse and neglect of individuals with developmental disabilities has become an issue that negatively affects the health and well-being of such individuals."

Two approaches to the problem:

Increase visitation of clients through enhanced case management in Developmental Disabilities Administration and

Create independent Office of the Developmental Disabilities Ombuds -Disability Rights Washington chosen as contractor in 2017.

DD Ombuds created - RCW 43.382

- Private, non-profit contracting with the State (Department of Commerce)
- Independent of the service system
- Provide DD Ombuds services statewide
- Exercise independence and authority
- Protect confidentiality

Who Do We Serve?

- People with Developmental DisabilitiesChildren
 - Adults

All living arrangementsReceiving any state service

Powers and Duties

Provide information on rights and responsibilities

- Investigate complaints
- Address complaints and resolve issues at the lowest level possible
- Monitor service delivery
- Review state institutions, state-licensed facilities, and residences
- Report on services to people with developmental disabilities
- Publish reports on systemic issues to the legislature
- Make recommendations for changes in policy and procedures.


Plans for Growth

Specific requirement to expand the program to use volunteers

Model program on the Long-term Care Ombuds program - Regional Ombuds, Paid staff, Significant volunteer force.

DD Ombuds

- Works for the interests of people with developmental disabilities.
- Informs the legislature to ensure safe, quality services.
- Reaches people with developmental disabilities who may not have a way to contact us.
- Focus on issues of abuse and neglect.

Some of what we did last year.

- Developed information on rights and responsibilities.
- 106 training and outreach events reaching over 2,000 people.
- Monitored 348 residences and facilities.
- Handled 130 individual complaints and 17 group complaints benefitting 345 people.
- Identified systemic issues

Systemic issues identified for continued work include:

- Systemic Report: <u>"Diverting Crisis Maintaining housing and supports for people with developmental disabilities"</u>;
- Systemic Report: <u>"Stuck in the Hospital</u>";
- Staff shortages and staff turnover in certified residential settings;
- Access to activities and social engagement;
- Access to behavioral supports and access to mental health care;
- Simplification of the eligibility process for DDA services;
- Address abuse and neglect, especially procedures for handling physical assault by one roommate against another in residential settings.

Some of the issues we have worked on with individuals and groups

- Lack of privacy
- Confidentiality
- Respect and dignity
- Abuse, neglect
- Service plan
- Transfer/Discharge
- Provider decertification

Continued work

- Regular meetings with Developmental Disabilities Administration, Adult Protective Services, Complaint Resolution Unit, Residential Care Services to share information identify systemic issues, and make recommendations for improvements.
- Collect data to use in reports and recommendations for improvements to the department, State Legislature, and Governor
- Develop information on rights website, videos, info cards
- Presentations to people with developmental disabilities, families, service providers
- Develop training and recruit and train volunteers
